*Premiere Bay Area Event Addresses Medical, Psychological, Estate Planning and
Legal Issues for Families Dealing with Dementia*



Description: A community conference designed to educate patients, families and the public on Dementia and the issues families face with aging parents, partners and family members. Speakers will include leading experts to address medical, psychological, estate planning and legal issues and the resources available for families dealing with Dementia.

The conference will focus on providing the community with answers to questions, such as:

- What is Dementia? Understanding the Medical, Psychological, and Legal Issues Confronting Families When a Family Member Begins Showing Signs and Symptoms of Dementia.
- What Legal and Estate Planning Issues Must Families Face When a Family Member Has Dementia?
- What Community Resources Are Available to Help Families Care for Their Family Member with Dementia?
- What Should Be Done When a Family Member Is the Victim of Financial Fraud or Undue Influence?

Priced at \$25 for individuals so that multiple family members may attend, the conference is designed to educate the public on Dementia and the problems people and families who suffer from it face. Speakers include Conference Chairman Dr. Abraham Nievod, J.D. of The Wright Institute, who will explain Dementia and address the issues of financial elder abuse and the vulnerability of individuals suffering from Dementia to undue influence; the Director of Marketing for the Alzheimer's Service of the East Bay, Micheal Pope, who will identify community resources available to those suffering from Dementia; Bette Epstein, Esq., Partner at Reed, Smith, Crosby, Heafey, L. L. P. and Patricia Ware, Vice President for Mechanics Bank, who will discuss the process of estate planning; and San Francisco's Deputy District Attorney, Diane Knoles, S.F.P.D.'s Detective Tom Feledy and Catherine Duggan, Esq., who will be exploring financial elder abuse and ways to prevent it.
